GRACE CHRISTIAN ACADEMY FINANCIAL POLICIES

The parent or guardian is responsible for all fees incurred by enrolling in GCA (enrollment fee, tuition, book and resource fees, and any other fees that may apply). These fees must be paid prior to the student beginning school.

- A student is not considered enrolled until all fees are paid and paperwork is turned in to the office.
- Enrollment fees are non-refundable for any reason.
- The full enrollment fee is due upon acceptance into Grace Christian Academy, regardless of what time in the school year the student enters Grace Christian Academy.
- Payments are due on the 1st of each month and a late fee of \$25 will be applied to any account that is not paid by the 10th of the month. A \$25 processing fee will be applied to any account not using online categories for Tuition and Book Fees. Students who have unpaid tuition and fees on the 20th of the month will be withdrawn from the active roll, will not be allowed to attend the Academy, and will be required to reapply and pay a new enrollment fee of \$100.
- We will only receive payment from the person with whom we have entered into this financial agreement. If you are receiving assistance for your child's bill from a grandparent or former spouse they need to make payments to you and you can make your payment to the Academy.
- Tuition payments may be made in one of three ways:
 - Delivered to the Academy personnel
 - Mailed to the Academy office
 - Online at gcapatriots.org
- All checks should be made payable to "Grace Christian Academy" unless otherwise specified.
- Returned checks will be charged a \$25 fee.
- Any family with one returned check may be placed on a "cash only" basis to ensure the student's continuation in Grace Christian Academy.
- Any lost or damaged books will be replaced by the student at the cost of the new book.
- For early withdrawal or expulsion, you will be responsible to pay tuition for the remainder of the month.
- For early withdrawal or expulsion, you will be responsible to pay the remainder of the \$300 book fee.
- If distance learning is necessary, tuition and book fees remain unchanged.
- Any account delinquent after 90 days will be turned over to a collection agency.
- The Academy reserves the right to change these guidelines as needed.
- Other fees may include but not limited to:
 - Back-to-School Retreat - \$100 per student
 - High School Graduation fee - \$75 (cap, gown, diploma, diploma cover)
 - K5 Graduation fee - \$25
 - Team Sports Athletic fee - \$50 per sport
 - Stanford Achievement Testing - \$30 per student (1st – 12th grade)
